

INFORMATION ON THE PROCESSING OF PERSONAL DATA REGULATION (EU) 2016/679.

Pursuant to articles 13 and 14 of EU Regulation 679/2016, General Regulation of Data Protection (hereinafter "GDPR"), in relation to the communicated personal data, "Acquafresca Sport Center acsd" (hereinafter referred to as "ASC acsd") as data controller provides the following information:

1. PERSONAL DATA

Personal data, as defined by article 4 no. 1) of the Ddpr, provided by the user will be processed in compliance with this information and in any case in compliance with current legislation on the protection of personal data.

2. PURPOSE

The data will be processed for institutional purposes, connected and instrumental to the activity of the ASC acsd and in particular:

- a) for purposes strictly connected to the mission of the Association and included among the statutory purposes;
- b) for the fulfillment of the obligations established by laws or regulations to which the Data Controller is subject (article 6 letter c) of the GPCR (legal obligations).

3. DATA COMMUNICATION

The data will be communicated, in compliance with its institutional purposes, to all the subjects necessary for the fulfillment of the statutory obligations, for which the data is acquired.

The scope of data communication will be strictly necessary for the execution of the Association's assignment conferred to the third parties indicated above, within the scope of the purposes referred to number 2 a) and b).

Furthermore, the ASC acsd upon specific request, communicates the data to the competent Authorities for the fulfillment of the obligations imposed by law.

4. NATURE OF THE PROVISION OF DATA

The consent to the processing of data for the purposes referred to the previous point 2 letter a) and b) it is not necessary pursuant to article 6 of the GDPR.

5. MODALITIES OF PROCESSING

The data will be processed both on paper and in electronic and/or automated mode, directly and/or through the third parties indicated above.

The data may be processed and organized in databases, and treated in compliance with the principle of proportionality and, in any case, for the time necessary to carry out the statutory activity, and in any case until the specific consent is revoked by the user.

6. STORAGE PERIOD

The processing's storage period for statutory purposes coincides with the duration of the associative or contractual relationship, while the one linked to the fulfillment of legal obligations and prescribed by the Law.

7. DATA CONTROLLER

The data controller is "Acquafresca Sport Center acsd" with registered office in Loc. Acquafresca n. 3 Brenzone sul Garda VR; for any communication regarding the protection of personal data, the email box is available at:

8. RIGHTS OF THE DATA SUBJECT

At any time, the user can exercise his/her rights towards the data controller, pursuant to article 15 and following of the GDPR.

In particular, each interested party has the right to access personal data, to rectify or cancel them, or to limit or oppose their processing, in addition to the right to data portability.

The user also has the right to lodge a complaint with the Personal Data Protection Authority.
